## FOR INTERNATIONAL STUDENTS REQUESTING F-1 VISA STATUS

International students are responsible for all educational and personal expenses for the duration of their F-1 status at the University of Minnesota Rochester. In order to issue an I-20, which is needed to obtain an F-1 student visa, the University of Minnesota Rochester is required by the United States government to maintain records that demonstrate that you have at least the funds necessary to cover your tuition, fees, and living expenses for your first year of study (12 months). If you attend summer session and/or bring your spouse or other dependents with you to the United States, you must also demonstrate that you have the funds necessary to cover those costs.

To show that you have sufficient funds for your first year of study at the University of Minnesota Rochester, complete and submit this form to the UMR Office of Admissions. Please note that forms that are incomplete or that do not show sufficient funds will be returned. **Do not send bank statements.**

You must submit this form to be considered an applicant for admission at UMR, but does not affect your admission decision. I-20s are issued by the University of Minnesota Rochester after admitted students have confirmed their enrollment and resubmitted this form.
